

## WISCONSIN ALL-STATE TRAPSHOOTING TEAM OFFICIAL APPLICATION INSTRUCTIONS

- A. Minimum target requirements must be shot prior to September 1.
- B. Request personal shoot records from A.T.A. Office by November 1<sup>st</sup>. You will require time to take care of average corrections.
- C. Applications are due by December 31<sup>st</sup> with all corrections confirmed by A.T.A.

All-State Team selection is based upon these completed applications. Accuracy, truth and honesty are paramount. Misrepresentation of fact may result in suspension of A.T.A. shooting privileges by the W.T.A. Board of Directors.

### QUALIFICATION REQUIREMENTS

- Step 1. You must be a resident of Wisconsin prior to March 1<sup>st</sup> of the target year being applied for.
- Step 2. You must have shot the three Championship events at the Wisconsin State Tournament in the year under consideration. (Friday Doubles, Saturday Singles and Sunday Handicap Championships.) If you missed one, you are not eligible.
- Step 3. You must shoot the Championship Events at one or a combination of multiple Wisconsin Zone Shoots.
- Step 4. The team for which you qualify will be based first on your category and second on your gender (for example, a Lady Veteran will be placed on the Veteran team if her average is high enough. If not, she will be placed on the Women's team if her average is high enough).
  - a. SUB-JUNIOR: A person who has not achieved his/her 15<sup>th</sup> birthday by the first day of the target year being applied for.
  - b. JUNIOR: A person who has not achieved his/her 18<sup>th</sup> birthday by the first day of the target year.
  - c. VETERAN: A person who has achieved his/her 65<sup>th</sup> birthday during the target year.
  - d. SENIOR-VETERAN: A person who has achieved his/her 70<sup>th</sup> birthday by Sept. 1st.
  - e. WOMEN: A female who has achieved her 18<sup>th</sup> birthday.
  - f. MEN: A male who has achieved his 19<sup>th</sup> but not his 65<sup>th</sup> birthday.
- Step 5. A candidate must have shot the following minimum regular registered and/or registered league target requirements during the past target year including the IN WISCONSIN MINIMUMS noted:

**If you fail to meet these minimum target requirements, do not proceed as you will not qualify.**

- Step 6. Calculate your ALL-AROUND AVERAGE. Simply add your three (3) ATA averages together and divide the AVERAGE TOTAL by (3). Example: 94.20 + 88.05 + 91.05 = 273.30, divided by 3 = 91.10

Step 7. You must have at least the following MINIMUM ALL-AROUND AVERAGE in your category to be considered for the All-State Team.

SUB-JUNIORS.....	70.00%	WOMEN, VETERANS & SR. VETERAN.....	85.00%
JUNIORS.....	80.00%	MEN.....	92.00%

**IF YOU HAVE NOT ATTAINED THESE MINIMUM REQUIREMENTS, DO NOT PROCEED**

Step 8. The target year ends on August 31<sup>st</sup>. Around the third week of October, the A.T.A. Office should have all the scores in their possession. Contact the A.T.A. office prior to November 1<sup>st</sup> and request a copy of your shoot record for the past year. They will ask for your name, state and A.T.A. number. Be sure to request this information before November 1<sup>st</sup> as there may be corrections required. A written request may be sent to:

Step 9. Upon receipt of your ATA shooting record, compare your personal shoot card with their record. If all is correct, proceed to Step 11 below.

**IF THERE IS AN ERROR OR PROBLEM, PLEASE DO THE FOLLOWING:**

Contact the WTA Secretary/Treasurer, Arlene Otto, at 1015 Bay View Ct., Mukwonago, WI 53149, Teleph: 262-363-1303 or e-mail: [aotto@centurytel.net](mailto:aotto@centurytel.net). Provide her with the shoot date in error, the club location, the event(s) in question, the ATA's recorded score and the score you believe you shot. If the error is an ATA recording error, the Secretary/Treasurer will follow up and have the score(s) corrected. If the error is a club recording error, it is YOUR responsibility to correct the error with the club involved. The Secretary/Treasurer will provide you with the name of a person, and address and a phone number to contact. Upon contact with the club, if the club's recorded score(s) disagrees with your record, the club must check the bulletin sheets and your individual score(s). This is the Official record. If the club has not made a counting error, the score stands as reported. However, if the club has made an error, the CLUB MUST report the error in writing to the ATA Office with copies to the Secretary/Treasurer and the ATA Delegate. Make certain the club follows through or the corrections will not happen. Once you have confirmation from either the Secretary/Treasurer or the ATA Office correcting the error, attach the correspondence to your ATA shoot record printout.

Step 10. Fill out the attached application form very carefully. Omissions could result in a candidate not being selected to the team. Forward the following information to Jay P. Adams, E7201A Oak Knoll Dr, Viroqua, WI 54665.

1. Wisconsin All-State Application Form
2. Duplicate copy of your shoot record from the ATA Office or Shooter Information Center
3. All correspondence regarding corrections to your shoot record. (Note: if corrections are not properly made, the Selection Committee has no alternative but to use the information which is at its disposal.

**Important:** All applications must be completed and postmarked prior to midnight December 31<sup>st</sup>. Applications received after that date will be returned and not considered. **NO EXCEPTIONS**

**Note:** Applications must be filled in completely and correctly. Do not include attachments or provide information not required and/or requested on the form.

Thank you for your time and cooperation. Good luck and congratulations on your fine shooting accomplishments. The All-State Team will be selected and announced in February.
